

## Event Duration and Enrolment

Event Duration and Enrolment. From Aug. 15<sup>th</sup> – Sept. 30<sup>th</sup> , 2024 (GTM +8), participants may enrol in the “MSI Claw Fallout Limited Edition\_Lucky Draw” event (“Event”) located at <https://in.msi.com/Promotion/2024-claw-special-offer/nb> . ## 1. General Terms Applicable to the Events

- i) Eligible Regions: worldwide, excluding Italy, Thailand, Turkey, People's Republic of China, Russia, Belarus, Cuba, Iran, Syria, North Korea, and restricted, sanctioned or embargoed countries or regions. Proof of residency may be required.
- ii) Draw prize is warranted against manufacturing defects for a period of one (1) year from receipt. External casing is excluded from this limited warranty.
