

## Event Duration and Enrolment

Event Duration and Enrolment. From Aug. 15<sup>th</sup> – Sept. 30<sup>th</sup>, 2024 (GTM +8), participants may enrol in the “MSI Claw Fallout Limited Edition\_Lucky Draw” event (“Event’) located at <https://www.msi.com/Promotion/2024-claw-special-offer-new/nb>. ### 1. General Terms Applicable to the Events

- i) Eligible Regions: worldwide, excluding Italy, Thailand, Turkey, People's Republic of China, Russia, Belarus, Cuba, Iran, Syria, North Korea, and restricted, sanctioned or embargoed countries or regions. Proof of residency may be required.
